TO BE EFFECTIVE ADVOCATES, WE ENGAGE THE PUBLIC THROUGHOUT THE YEAR IN EDUCATIONAL PROGRAMS THAT FORM THE UNDERPINNING FOR THE COMMUNITY'S UNDERSTANDING AND APPRECIATION FOR HISTORIC PLACES AS WELL AS HIGH-QUALITY URBAN ENVIRONMENTS. IN 2019, OUR PUBLIC ENGAGEMENT PROGRAMS -INCLUDING THE SITES AND STORIES INITIATIVE - SERVED MORE THAN 1300 PEOPLE. 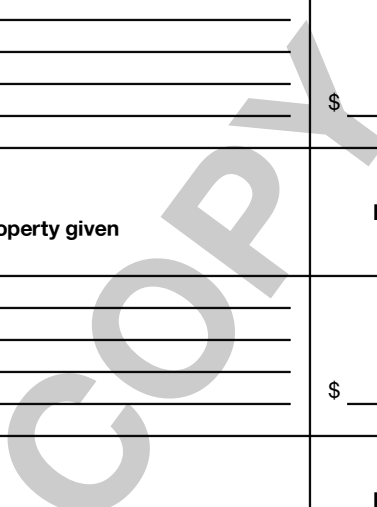
