TO BE EFFECTIVE ADVOCATES, WE ENGAGE THE PUBLIC THROUGHOUT THE YEAR IN EDUCATIONAL PROGRAMS THAT FORM THE UNDERPINNING FOR THE COMMUNITY'S UNDERSTANDING AND APPRECIATION FOR HISTORIC PLACES AS WELL AS HIGH-QUALITY URBAN ENVIRONMENTS. IN 2018, OUR PUBLIC ENGAGEMENT PROGRAMS - A SPRING LECTURE SERIES, SITES AND STORIES INITIATIVE, AND PROVIDENCE SYMPOSIUM - SERVED NEARLY 2200 PEOPLE.
